1. Subject to the conditions set out below **The Company Guarantees** that the products supplied will be **free from inherent defects in materials and workmanship** for a period of **10 Years**.
2. **Safety Glass Requirements:**

All Glass will be manufactured and supplied in strict accordance with BS 6262, BS 6206 and Section N1 of Approved Document N of the Building Regulations - which between them specify the Safety Glazing Requirements for all areas of "Special Risk," including "Low Level Glazing" and "Bathing and Washing Areas."
 - B. where the Company has both surveyed for and installed the products it shall be responsible for 2 (A) above.
 - C. in any other circumstance including but not limited to DIY and Trade Supplies the Customer shall be responsible for 2 (A) above.
3. **Sealed Glass Units - Company Installation**

The Company guarantees that all Sealed Glass Units Installed by the Company will be free from inherent defects in Workmanship and Installation Materials for a period of 10 years.
4. **Sealed Glass Units - Customer Installation**

5. **Sealed Glass Units - The Customer(s) Responsibilities**

It is an Implicit Term of this Guarantee that Customer(s) will ensure that all frames into which Sealed Glass Units are installed are properly maintained in accordance with the original supplier's instructions or in accordance with common practise.
6. **Guarantee Transfer**

If the property where the products have been installed changes ownership then the remaining term of the guarantee is **Transferable to the new owner/s without Charge**.
